The following Tax Structure for 2023 is published in accordance with section 109 of the **Municipalities Act** and adopted by a minute of Council on December 21, 2022

<b>Property Tax:</b>	6.65 mills of assessed value
Minimum Property Tax	\$375.00 per year
Minimum Vacant Land	\$35.00 per year
<b>Business Tax:</b>	Minimum \$100.00
Gas Bars/Garages/ Body Shops	8 mills
Utility/Cable Companies	2.5% of gross revenue
Oil Companies	60 mills
Rental Units	\$100.00 per unit
Seasonal Cottages/Bed & Breakfast/Airbnb	\$100.00 per unit
Business no fixed place	1/4 of 1% of gross revenue of business for prior year or \$100.00, whichever is greater.
All others	10 mills

<b>NSF Cheque:</b>	\$40.00 minimum (Bank Fee and Town Processing Fee)

All taxes are due and payable in full on or before **March 31, 2023** after which they are considered in arrears.

A 5% discount will be granted on 2023 property and water/sewer if paid in full by the due date.

Interest of 1% per month will be charged on the unpaid balance of 2023 property tax after the due date unless an agreement has been made to pay in 12 equal monthly installments starting January 28, 2023.

Accounts in arrears or without a payment schedule in place will be subject to disconnection of water services and/or referral to collection services at Council's discretion.

Only payment made in Canadian currency will be accepted.
